In return for being allowed to participate in any way in The Berkeley Ski Club, in any Berkeley Ski Club sponsored activities or related events, or to use any facilities of the Berkeley Ski Club:

1. I agree that prior to participating in any event or using any facility, I will inspect the facilities and equipment to be used, and if I believe that anything is unsafe, I will refuse to participate or use the facility. If I discover an unsafe condition at any time, I will stop participating in the activity, or leave the facility. I will promptly notify a club representative of the unsafe condition. If I continue to participate or use the facility, I understand that I am assuming the risk of any injury that may happen as a result.

2. I acknowledge that I and other club members or guests may be engaging in activities that involve risk of serious injury to me, including permanent disability and death. I understand that these risks may be increased through my own actions, or through the negligent action or inaction of other Berkeley Ski Club members. I am willing to assume all risks of injury or loss, even if caused in whole or in part by the negligence of the Berkeley Ski Club or its members.

4. California Civil Code section 1542 states:
